Hi Cinna,

My name is Melissa Pearson, I am a consultant planner engaged by the Far North District Council (FNDC) to be the reporting officer on the Heritage topic, the hearing for which is currently scheduled for May 2025. I'm working with a heritage expert on behalf of the FNDC to assess the requests for amendments to heritage provisions in the Proposed District Plan (PDP), including the Heritage Area overlays. From reading your submission I understand that you are particularly interested in the Heritage Area proposed to protect Te Waimate.

Part of being able to assess requests to amend Heritage Area overlay boundaries is understanding the spatial extent of such requests. Sometimes this is difficult for us to do when the requested changes are described in words, as opposed to being shown on a map. To ensure that we clearly understand the scope of your submission, we request further clarification as to the boundaries of the Te Waimate Heritage Area that you support, down to a land parcel specific level of detail. In particular:

- The extent of the valley north of the Mission Station (to the bush and ridge) that you wish to be included. We require more information than the direction that the overlay include Courthouse Lane and extend as far as the school (near the intersection of Waimate North Road).
- The extent of the farm/valley directly opposite the Mission on Te Ahu Ahu Road (formerly 'Cook's Farm') that you seek to be included.
- The location of the cluster of ancient trees where local Maori left their tūpāpaku/dead.
- Clarification of how you wish to protect the view shafts in Te Waimate. Your submission suggests that these were protected under the old 'special zone' in the Operative District Plan, however the notified Te Waimate Heritage Area overlay encompasses the entirety of the operative zone so it is not clear if you are requesting additional land be included to protect the viewshafts or if you are seeking that some of the Operative Plan wording is rolled over relating to view shafts?

Based on the written description in your submission, we have attempted to show the Te Waimate Heritage Area overlay as requested in your submission (additional area shown in black, notified area shown in purple) but this is a very rough first estimate. Please confirm whether this accurately reflects the additional land that you are seeking to be added to the Te Waimate Heritage Area overlay. A hand mark up of the map below is fine to correct any assumptions that we have wrong, this can be scanned (or photographed) and emailed to me, or dropped off to a Council service centre where they can scan and email to me on your behalf. Also, if you have access to any of the historic maps/plans that you alluded to in your submission that show these features, please supply these to better support your submission.





**Cinna Smith: CLARIFICATION RE MY SUBMISSION TO EXTEND TE WAIMATE HERITAGE AREA**



**I have drawn a red line to indicate my requested extension to the black area identified on the map you sent. Specific Parcels of land are listed in Appendix 1. Reasons for the inclusion of this area:**


- This area is crucial to preserving the view shafts of Waimate North - these view shafts have been recognised as nationally and internationally significant and deserving of protection. They are culturally significant to both Māori and Pākehā.
- Horticultural developments are already starting to negatively impact these view shafts with their imposing structures including tall posts and large white overhead canopies, as seen in the below photo from TradeMe property listing <https://www.trademe.co.nz/a/property/rural/northland/far-north/waimate-north/listing/4733513144>, which shows how the extent of the overhead canopy of a kiwifruit orchard on Te Ahu Ahu Road directly opposite the existing heritage area. This canopy can be seen from kilometres away.




- Parcels of land included in my proposed extension area form part of the original Mission station farm and were part of the first pastoral farms in New Zealand. In pre-European times, the area was successfully farmed by Māori. It is my understanding there are items of archaeological significance there – please clarify with Heritage New Zealand.
- The proposed extension includes a sacred wāhi tapu grove of trees on the corner of Whakataha and Te Ahu Ahu Roads (evidence of their significance is included below).
- The proposed area includes the first vehicular (cart) road in New Zealand (now Cook's Lane) and included the first bridge in New Zealand (Clarke's Bridge).
- The proposed extension area includes the site of the Paremata flour mill (photographic evidence below).
- The new water reservoir under construction on Te Ahu Ahu Road may enable more horticultural developments. It is urgent that measures are put in place to protect Te Waimate's view shafts before they are lost, which would be a tragedy given Waimate North's historical significance and its culturally significant landscape, which deserves to be protected for future generations.

**EVIDENCE OF SACRED TREES**

This model refers to the ‘knoll and sacred grove’ – far right bottom.



**Another reference to the tapu bushes, source Te Waimate Mission Station**

Angela Middleton's *Pewhairangi Bay of Islands Missions and Māori 1814 to 1845* (Otago University Press 2014) mentions the sacred trees (p175). Moka (one of three Rangatira who signed the land deed for Waimate to enable the creation of the mission), was concerned a wahi tapu, sacred place of trees, "that should not be touched or walked through, and the area was noted in the land deeds. This was an ancient place in which bodies were left after death for the flesh to dry from the bones before the hahunga."



## **FARMLAND IN THE PROPOSED EXTENSION AREA WAS:**

- farmed prior to European arrival
- part of the original mission farm
- where pastoral farming was first conducted in New Zealand
- formed an integral part of the vistas that Te Waimate became renowned for

### Sources:

- According to Angela Middleton's *Pewhairangi Bay of Islands Missions and Māori 1814 to 1845* (Otago University Press 2014), Te Waimate was Hongi Hika's principal inland area for growing food (p171) and one of his primary residences. In 1815, Samuel Marsden noted fenced fields planted with potatoes, turnips and kumara. Hongi was growing wheat from seed Marsden had sent him.

- This newspaper article refers to land across from Faithfull's Store (now The Old Store, 372 Te Ahu Ahu Road ) being given by Hongi Hika to the missionaries for growing wheat. - In pre-European times the area likely formed part of rangatira Tāreha's farm (he lived in Whakataha Pa near the northern most tip of the proposed extension area). <https://nzhistory.govt.nz/politics/declaration/signatory/t%C4%81reha>
- Samuel Marsden visited his 'farm' in 1815 and 1820 and described the pa as having "much rich land round it." He also described the scenery as "sublime." <https://www.biodiversitylibrary.org/page/62704473#page/10/mode/1up> p 4
- In the 1830s, the Waimate Christian mission farm was 1300 acres (M W Standish, the Mission Station 1962, p 23).
- In 1835 missionary George Clarke (who lived in one of the mission houses) wrote "*in front of our house we have cows and sheep grazing on a beautiful field of English clover and our horses and carts moving backwards and forwards as on an English farm.*" G Clarke letter to father, 8 May 1835, Waimate Mission House archive.

The following images illustrate how the farmland in the proposed extension area formed part of the original mission station, was the site of the first European pastoral farming, and contributed to the remarkable view shafts.



*Cyprian Bridge sketched this idyllic 1845 scene (later made into an engraving), showing sheep resting in the shade of the trees at the Waimate North Mission.”*







### **FIRST ROAD IN NEW ZEALAND**

- The proposed extension area has the first vehicular/cart road in New Zealand running through it.
- *“The station became a sizeable village ... with the farm that extended all around it. A cart road into it from Kerikeri was the country’s first road.”* P 133 ‘Tides of History’ by Kaye Boese, Bay of Islands County Council 1977 (evidence cited IMO Pioneer relics at Waimate North AA Bulletin April 1957 p 10)
- It was built in 1830 by missionaries Clarke and Hamlin with Māori help p8 <https://wdc.recollect.co.nz/nodes/view/1716#idx12070>
- This newspaper article refers to the first road in New Zealand – now known as ‘Cook’s Lane’ and part of the proposed extension area <https://paperspast.natlib.govt.nz/newspapers/EP19340517.2.40>

- The bullock track between Kerikeri and Te Waimate is still visible where it crosses the Waitangi River.

## **WAIMATE NORTH VISTAS RECOGNISED**

- Early Waimate was described as “*rich and picturesque, situated in an extensive plain, surrounded by all the beauties that nature can present.*” (sources listed p65 of this report) – from J Preece and Rev W Yates


*“The country passed through to-day presents in many parts a beautiful park-like effect. The grass paddocks are dotted with dumps of native trees, especially purine, -which are particularly beautiful, reminding one of a group of oaks. An Englishman with the party said that the landscape of Waimate North, the longest settled and most beautiful part of this region, reminded him greatly of the tree-studded and wood-adorned English) countryside. Waimate is the inland gem of the cultivated North. Land there is so good that it has been cultivated in places for seventy year\* without manures.”*

- Charles Darwin visited in 1835 and commented on the views “*it’s well-dressed fields, placed there as if by an enchanter’s wand.*” Darwin mentioned the adjoining slope having fine crops of barley and wheat, potatoes and clover. Darwin article -

- The Northern Luminary 11 Nov 1884 described Waimate North as a “*picturesque settlement*” ... “*the place has a park-like appearance – groves of puriri trees here and there, meandering streams, rich meadows, pleasant homesteads, well kept flower gardens, and rich shrubberies, the church steeple towering over all.*”






## **TOURISM POTENTIAL OF WAIMATE NORTH**

- The attached council document 566-TCPPA-Permits and Decisions contains information about the historical significance and tourism potential of Waimate North. In 1976, the Mission attracted 27,000 annual visitors (p9 of 566-TCPPA-Permits and Decisions report).
- The current management of Te Waimate Mission are working hard to build the profile of the site and attract visitors with many events and activities.
- There are other culturally and historic areas in Te Waimate that may one day be incorporated into tourism offerings.
- Protecting the view shafts of Waimate North is therefore critical to harness the benefits of tourism, and to protect significant cultural landscapes for future generations.

There is another wahi tapu area marked on this map (52) within the proposed extension area that may require investigation

- (3) That the building be repaired and painted, such work to be in harmony with the historic character of the old country store.
- (4) Compliance, particularly for the purposes of a shop, with all relevant acts, bylaws and regulations."



Subject of application.

The applicant seeks to establish a shop in an old country store in the vicinity of the historic tourist attractions of Waimate North. The land is at present being grazed, while the store is vacant. The road is sealed for parking in front of the store and it has a rustic charm. The site of 857.4 square metres is zoned Rural A in both the operative and reviewed District Schemes.

The purpose of the Rural A Zone is (according to the zone statement) as the general farming zone of the district. The proposed use is neither designed for the day to day service of rural customers nor for the necessary servicing of the travelling public, criteria under which the establishment of a commercial use would have to be viewed.

The type of shop proposed should be sited, in accordance with the District Scheme, in the commercial area of one of the townships of the Bay of Islands or in Kaikohe Borough. The intrusion of a specialty shop into a rural zone would have planning significance beyond the vicinity of the land concerned and the provisions of the scheme could not remain without change.

STATEMENT OF EVIDENCE BY RONALD HOPE-LEWIS

I am the owner of Lot 1, D.P. 45179, Block V, Kawakawa S.D.  
Waimate North, which is the subject of this application.

I have been associated with the property since 1934 which I  
conducted as a general store for 37 years until 1971, when owing to the  
pressures of conducting two businesses and an illness in the family it  
was reluctantly decided to lease the Waimate Store to my assistant.

The Store was conducted by her up until two and a half years ago  
when ill health and the inability to continue forced her to close the  
business.

The site has been a general Store for over 100 years and the Store  
as it is now was built in the eighties of last century by Mr William Cook  
for Mr Atkinson and is the only example left of a country Store of that  
period in Waimate. The interior is largely as it was built with kauri  
shop counters, high shelving, exposed pit sawn ceiling joists and hand  
dressed timbers. The flooring is fastened with ewbank nails.

The Store is a contemporary of the fine old Atkinson Homestead,  
which is adjacent.

The historic oak tree which was planted by Rev. Davis in the  
1830's is only 150 yards away and is a regular attraction for visitors.  
The Store is in the centre of historic Waimate near the old Church and  
Mission House which is visited by thousands each year.

When I conducted the Store there was a steady demand from Tourists  
for some memento of their visit to Waimate and they like to purchase these  
mementos where the history occurred. If there is ever a place so steeped  
in history it is Waimate, you have only to walk around the lovely Church,  
the resting place of many of our early pioneers and the names on the head-  
stones both Pakeha and Maori bring one close to the early days of New Zealand.

I propose, subject to this departure being approved by Council to sell the property to Mr Geoffrey Harvey, a resident of Waimate North for the purpose of opening an Arts and Crafts and Souvenir Shop that will give a useful outlet for handicrafts of local people and meet a need of the travelling public.

The use of the building as an Arts and Crafts and Souvenir Shop, as proposed, would enable building to be kept in similar state to long standing use and be put to an economic use and be retained rather than be absorbed into an adjacent farm or fall into disrepair and be lost forever.

The evidence shows that relevant to Section 35 of the Town and Country Planning Act 1935<sup>53</sup> that:

- (a) The past history of the building and the intended type of shop will not be contrary to public interest.
- (b) The matter is a special case, in that the building is the only one of its type in the area. Waimate North is one of the most important historical areas in the Country and in these circumstances, approval of application should not result in any planning precedent as same or similar circumstances are unlikely to again arise.
- (c) For same reasons as (b) above provisions of scheme can justifiably be left unchanged.

If the Council gives their approval the following are suggestive conditions:

- (a) Parking area on road already formed. Therefore conditions in this respect not necessary. *Tarsealed area off-street.*
- (b) That building be repaired and painted in line with intentions detailed in Mr Harvey's evidence to the satisfaction of Councils Officers or Council.
- (c) That any relevant by-laws will be complied with by Mr Harvey.

STATEMENT OF EVIDENCE BY J.G. & E.H. HARVEY

We are residents of Waimate North and subject to approval by this committee of a Specified Departure wish to purchase the old Waimate North store with a view to operating it as an Arts & Crafts & Souvenir shop. We propose that the shop be restored as far as possible to its original condition. The shop would stock such items as pottery, leatherwork, woodcraft, weaving, handmade clothing, Maori artifacts and craftwork and a limited variety of topical souvenirs and photographs of local interest etc.

Need for Craft Shop - Despite limited publicity many people have already registered approval of the fact that there could be a local sales outlet for their handiwork available. In particular the local Maraes have indicated they will supply material for the shop which they hope will promote their culture amongst their youth. These lines are not now available at Waimate North and are in demand by visitors to this historic area.

We intend to display items of local historic interest including early agricultural machinery and this would make an interesting display.

The Craft Shop would serve as an added attraction to a notably historic area which is already of considerable tourist interest. The Mission House had 27,000 visitors last year and is increasing yearly many of whom could be expected to appreciate local handcrafts. The shop is ideally situated for this as it is only 400 metres from the Mission House. People like to buy where the history is and a shop of this type in a commercial area such as Kaikohe or Ohaeawai would not have this advantage and would be swallowed up amongst a plethora of other businesses. It is the only wooden example of an early pioneering New Zealand country store in close proximity to a major tourist attraction situated as it is in the centre of Waimate North.

The building is of great historic interest with its pit sawn and hand dressed timbers and if left unused will only deteriorate further and will eventually be lost to posterity for ever. Apart from a commercial undertaking of some kind the building could only be used as a hayshed or storehouse. Plans are already underway to restore the building many quotes having been obtained already and some materials purchased. The repairs proposed will be in harmony with the past character of the building and consist of repairs to the verandah, reblocking where necessary, repairs to roof, weather boards and painting.

We feel this is an exceptional circumstance as we are utilising an existing amenity which is in keeping with the historical nature of the area rather than creating a modern facility.

We propose to open from 10a.m. to 4p.m. daily with extended hours for weekends and public holidays. This would complement the Mission House hours and provide an interesting opportunity to fill in the two hours between 12noon and 2p.m. daily when the Mission House is closed for lunch and many tourists sit in their cars waiting for it to re-open.

We stress that our intentions are community orientated rather than solely commercial.






My name is Melissa Pearson, I am a consultant planner engaged by the Far North District Council (FNDC) to be the reporting officer on the Heritage topic, the hearing for which is currently scheduled for May 2025. I'm working with a heritage expert on behalf of the FNDC to assess the requests for amendments to heritage provisions in the Proposed District Plan (PDP), including the Heritage Area overlays. From reading your submission I understand that you are particularly interested in the Heritage Area proposed to protect Pouerua.

Part of being able to assess requests to amend Heritage Area overlay boundaries is understanding the spatial extent of such requests. Sometimes this is difficult for us to do when the requested changes are described in words, as opposed to being shown on a map. To ensure that we clearly understand the scope of your submission, we request further clarification as to the boundaries of Pouerua Heritage Area that you support, down to a land parcel specific level of detail.

Based on the written description in your submission, we have attempted to show the Pouerua Heritage Area overlay as requested in your submission – it appears that you support the northern extension of the heritage area overlay but not the southern extension. Based on a comparison of the Operative and Proposed boundaries, we have assumed that you support the northern boundary of the overlay as notified in the Proposed Plan (shown as a black, solid line below), but would prefer the rest of the boundary to follow the Operative Plan line (shown as a dotted black line).



Could you please confirm in writing that we have accurately interpreted your submission? Alternatively, if we have incorrectly assumed the scope of your submission the best way to clarify the scope would be a marked-up map that showed the new overlay boundaries that you are seeking. This can be hand marked up (if that's the easiest option for you) and can be scanned (or photographed) and emailed to me, or dropped off to a Council service centre where they can scan and email to me on your behalf.

Please find the information you requested on the scope of our submission and let us know if this is satisfactory.

The area included by the yellow line on the map, bounded by Court House Lane, Whakataha Road, part of the Waitangi River, part of Waimate North Road, and part of Te Ahu Ahu Road.

This includes, Cook's Lane (part of the New Zealand's first vehicular road down to the Waitangi River, the catchments of the Waipatukahu and Waihirore streams, important parts of the Mission farm, the first pioneering European type farm in New Zealand and associated vista, the first and second site of the water wheel driven flour mill and biscuit factory, ditch and wall fence, a marae, one urupa that we know of, another sacred small tapu grove of trees associated with the dead, surviving evidence of traditional Maori cultivation (kumera pits and terraced gardens and implements).

We have little doubt, there would be valuable new discoveries, if properly investigated, before even more is destroyed by short term commercial interests, that place no value on this community and its heritage.
