1.0 Summary

The Pou Herenga Tai - Twin Coast Cycle Trail Trust (PHTTCCT) are the body responsible for the governance, overall direction, management and operation of the Pou Herenga Tai Twin Coast Cycle Trail (the Trail) a Far North District Council (FNDC) asset.

With support from FNDC, PHTTCCT have engaged Barker & Associates (**B&A**) to assist in ensuring the full potential of the Trail is realised. This has included the preparation of feedback on the Draft Far North District Plan (**Draft Plan**) dated 6 May 2021 which sought that the Trail be mapped in the plan as an overlay to acknowledge this regionally significant piece of infrastructure in accordance with the Northland Regional Policy Statement (**RPS**). PHTTCCT have since engaged B&A to prepare a formal submission on the PDP. In summary, the submission sought to have the Pou Herenga Tai Trail included as a mapped overlay with associated provisions and generally ensure a well-connected and integrated transport chapter.
