#### My submission is:

The submitter supports in principle the inclusion of provisions for helicopter landing areas set out in the proposal but considers that these need to be amended to remove potential ambiguity and provide greater clarity.

#### The submitter seeks the following decision from the local authority:

- The wording of the provisions in the second column of clause NOISE R7 should be
   amended to provide for landing areas that do not meet the standard PER-2 to be identified
   as restricted discretionary activities.
- 2. The wording of the provisions in the first column of clause NOISE S4 be amended so that it \$337.002 is clear that noise generated from helicopter movements comply with the limits set out standard NZS 6807:1994 when measured at any point within the boundary of the General Residential and Rural Residential zones, or within the notional boundary of any noise sensitive activity in the Rural Production, Rural Lifestyle, Settlement, Horticulture or Maori Purposes zones.

Rule NOISE-R7

- 3. The exclusion in the provisions in the first column of clause NOISE \$4 be amended so that: \$337.003
  - it refers specifically to standard PER 2
  - sub-clauses i and ii be deleted.

If others make a similar submission, I will consider presenting a joint case with them at a hearing.
