Submission:

I oppose changing zoned rural production land to SNA, I also oppose lifestyle block size properties being changed to SNA.

In our particular case it does not make practical sense for small titles of proposed SNA areas on Wainui Road near Ota Point Road to become SNA. The immediate local area is rural production, lifestyle blocks and sections in an area requiring more housing due to a substantial lack. This has obviously been recognised due to the close proximity of the new subdivision on Ota Point Road. Singling out a couple of small properties to be SNA beside a neighbour who is currently constructing a subdivision seem unreasonable. As stated in your plan the SNA proposal has been desk based and the 192 Wainui Road properties included as proposed SNA's seem lumped in due to this rather than a sensible and realistic assessment that feet on the ground at the titles at 192 Wainui Road, Kaeo would provide.

I want the properties at 192 Wainui Road to be withdrawn from the SNA proposed plan.
