To whom it may concern,
 I am unable to make a submission online under Josephine Clarke on the behalf of Ngati Rangi ki Ngawha.
 Statement the submission process is inadequate, with the short time frame, online only and not reflective of Te Tiriti as it lacks an appropriate qualitative way for engagement with Tangata Whenua.
 Please see below for my submission. Would like to do a verbal submission preferably in the morning, and open to shared submissions with like-minded

applicants.

Support in part the following clauses:

- **Tangata Whenua clause partly supported.** Engagement with Ngati Rangi ki Ngawha hapu needs to be improved particularly in regards to talking with mandated hapu representatives for Taiao (Liliana Clarke and Josephine Clarke), this includes but is not limited to the protection, and enhancement of our significant cultural landscapes, kainga, whenua and taonga in relation to our whakapapa. Tangata Whenua engagement needs to be improved, including Tangata Whenua's input on strategic planning, RMA reforms, Te Mana o te Wai etc. This needs to be respected and included in all Maori Frameworks for future development of our rohe. Ngati Rangi ki Ngawha has exclusive rights within our rohe, this includes the NIEP project, Top Energy extensions or future development, Ngawha Springs, NRCF, Matawii Dam, Northland Water Trust, Te Pukenga and any other future stakeholders coming into our rohe, as such we are statutorily required to be part to any consenting through FNDC process.  - Ngati Rangi ki Ngawha hapu will seek to create Mana Whakahono in particular a clause around Te Mana o Te Wai and us being a supplier within our Rohe. S515.002
 - Ngati Rangi ki Ngawha hapu will update and submit our Hapu Environmental Management Plan and cultural maps. S515.003
 - **NIEP Project clause partly supported.** Ngati Rangi ki Ngawha has exclusive rights within our rohe, we have a partnership with the NIEP however over the last year this has been at a loss as we do not support the road/entrance off state highway 12 through the wahi tapu/puriri grove of trees. This is a culturally significant site to our whakapapa and these trees need to be consulted directly for an alternative route without financial support from the developer. This is one of many examples that our taonga, whenua, kainga, whakapapa are not being respected or protected under Te Tiriti. S515.004
- Fully support Roxanne Drader's submission in regards to the NIEP Project as an affected neighbour and Ngati Rangi hapu member. S515.005
- Fully support Ngati Rangi ki Ngawha's submission by Liliana Clarke. S515.006 to S515.012
